We proudly present our 21st Annual Arizona Fine Art EXPO. The EXPO is held in North Scottsdale at the southwest corner of Jomax and Scottsdale Road next to MacDonald's Ranch. The show is located just 5 miles south of Carefree and 5 miles north of the Loop 101. The show is nestled in the most affluent, upscale neighborhoods of Scottsdale.

The application fee includes many opportunities for the artists over the ten weeks, such as a working studio in a lovely gallery setting, your art exhibited within the studio, art sales, paid staff assistance, extensive advertising campaign, artist's page within our EXPO website (www.arizonafineartexpo.com), patron interaction, camaraderie with fellow artists and patron contacts from sales. Unless other arrangements are agreed upon in advance, artists are strongly encouraged to be present **seven days a week** or have a studio sitter in their absence. A limited number of outdoor working cabanas are available for welding, clay & raku firing, patina finishing, glass fusing, etc. on a first come first serve basis.

There is no charge for the sculpture garden jury and no extra cost for the garden space if you have at least one paid studio. If you are juried into the sculpture garden but do not have a studio, a 30% commission will be charged.

ARTISTS' MARKETPLACE: To place some items in the Marketplace, it is important that everything is juried beforehand. Again, there is no charge for this jury.

I also understand that the final marketing payment is to be paid in full and that there will be no refunds after November 1, 2024
